Those of you who have submitted proposals to us before, please note that there are two new budget forms required this year (and another form no longer required). It is important that you have a look at the RFP to be sure you have incorporated these changes.

Following is the research proposal and review schedule:

- 1. All proposals due: November 15, 2004.
- 2. Preliminary Research Review (Moses Lake): <u>December 13, 2004.</u>
- 3. Revised "new" proposals and progress reports due: <u>January 15, 2005.</u>
- 4. Final Research Review (Pullman): February 10-11, 2005.

#### **Tuber Moth Numbers Continue to Climb**

As you have read in recent issues of this newsletter, potato tuber moth is becoming established in the Columbia Basin. At the beginning of the season, our pheromone traps were catching only one or two moths per week in the region north of Pasco. Catches have been climbing in recent weeks, with 65 moths caught in twelve different traps last week. For complete trap catch information, see the commission's web site, noted above.
